# Main Actions from Action Plan (PA 8) 1/2

- ➤ To foster cooperation and exchange of **knowledge** between **SMEs**, academia and the **public sector**
- ➤ To improve business support to strengthen the capacities of **SMEs** for **cooperation** and **trade**
- ➤ To support enterprises through high performing training and qualification schemes
- > To prioritise the effective implementation of measures provided for under the Small Business Act for Europe







# Main Actions from Action Plan (PA 8) 2/2

- > To improve the competitiveness of **rural areas** and in particular of the agriculture sector
- > To eliminate cross border barriers and bottlenecks to people and business
- ➤ To improve **framework conditions for SMEs** in areas where competitive infrastructure is missing **clustering**
- ⇒ Better use of existing initiatives such as the **South East European Centre for Entrepreneurial Learning SEECEL**







## Implementation • Framework 1/1

#### No new EU Funds

⇒ better use of existing funds is emphasised

#### > No new EU structure

⇒ The implementation is through existing bodies, whose complementarity must be maximised

#### > No new EU legislation

⇒ The Strategy requires no changes to EU legislation

Project status	Planning phase
Objective(s)	The primary objective is to provide an attractive transnational touristic offer in order to strengthen the touristic industry. Furthermore, the cultural exchange and the development of a comprehension for environmental protection measures represent crucial objectives of our initiative.
Benefits for the Danube region, Sustainability	All the region will profit from a better coordinated, more interesting and sportive touristic offer. Moreover we hope to intensify the cultural exchange among the citizens of the different Danube countries.
Instruments used	Geography Connect (special software), Distance measuring machine, and so forth
Funding (Total budget and shares)	This initiative is mainly financed by the local touristic industries (65 %) but also by state programmes (20 %). Moreover we are supported by the European Fund for Regional Development (15 %). The total budget from the beginning of the project in 20** till the foreseen completion in 20** amounts to about Euro 124 Mio.
